

MAST CMHT Adult Services. Complexity Factors and agreed rating

Lozenge title and complexity rating	When does this lozenge appear ?
>4 weeks - LOW COMPLEX	Show this lozenge when there is no recorded 'outcomed' contact from home CMHT staff in the last 4 weeks. Key worker-led care only.
DNax2 - LOW COMPLEX	Show this lozenge when the two most recent consecutive direct contacts are recorded as DNA.
>12 months - LOW COMPLEX	Show this lozenge when there is no recorded direct contact from home CMHT staff in the last 52 weeks. Consultant-led care only.
>12 weeks - LOW COMPLEX	Show this lozenge when there is no recorded direct contact from home CMHT staff in the last 12 weeks. Key worker-led care only
>20 weeks - LOW COMPLEX	Show this lozenge when there is no recorded direct contact from home CMHT staff in the last 20 weeks. Key worker-led care only.
18-25 - LOW COMPLEX	Show this lozenge when SU is aged between 18-25yrs.
ASD/LD- - LOW COMPLEX	Show this lozenge for SU with ICD diagnosis code F70-79 and F84 ever recorded in EPR.
CAMHS transfer- COMPLEX	Show this lozenge when there has been a referral to any CAMHS type team closed in the preceding 12 weeks, or there is a CAMHS referral that is currently open.
Child - LOW COMPLEX	Show this lozenge when relationship section in SystmOne shows that a child is recorded.
Clozapine - LOW COMPLEX	Show this lozenge when there is a S1 clozapine alert recorded.
Consultant Led Care	Show this when a SU has a Consultant associated with their care and is not allocated a key worker within the SU home CMHT using the SystemOne tick box. (Any SU open to MHIST will appear as KW Lead Care)
CJLT - LOW COMPLEX	Show this lozenge when: there is an open to referral to a team type CJLT (Criminal Justice Liaison Team)
CTO - HIGHLY COMPLEX	Show this lozenge when there is a CTO or S17a marked as current in the MHA event table for SU
CTO due - LOW COMPLEX	Show this lozenge when there is a CTO or S17a marked as current in the MHA event table and the end date for this Section is in less than 8 weeks time.

Complexity Factors and agreed rating

Dementia- LOW COMPLEX	Show this lozenge for SU with ICD diagnosis code F00, F01, F02 or F03 ever recorded in EPR.
DNA - LOW COMPLEX	Show this lozenge when most recent direct contact is recorded as a DNA.
Eating Disorder - LOW COMPLEX	Show this lozenge when: there is an open to referral to a team type ED.
Dementia- LOW COMPLEX	Show this lozenge for SU with ICD diagnosis code F00, F01, F02 or F03 ever recorded in EPR.
EIP transfer- COMPLEX	Show this lozenge when there has been a referral to any EI type team closed in the preceding 12 weeks, or there is an open EI referral.
HDAT	Show this lozenge when there is a S1 HDAT alert recorded
Housing - COMPLEX	SUSPENDED UNTIL DATA AVAILABLE
Lithium - LOW COMPLEX	Show this lozenge when there is a S1 Lithium alert recorded
MAPPA - HIGH COMPLEX	SUSPENDED UNTIL DATA AVAILABLE Show this lozenge when MAPPA activity is recorded as ticked in the safeguarding tab (this includes currently ticked only).
MHA history (last 12 weeks) - COMPLEX	Show this lozenge when there are no active MHA events (excluding s117) in the MHA event table, but there have been in the preceding 12 weeks.
MHIST- COMPLEX	Show this lozenge where the SU is open to MHIST
No allocated Worker - LOW COMPLEX	Show this lozenge when there is no staff associated with the SU at all in the care record.
No KW Allocated - LOW COMPLEX	Show this lozenge where the SU is on the KW-led care pathway but doesn't have a key worked allocated using the system 1 tick box.
Out of Area Placement - COMPLEX	Show this lozenge when there is an OOA inpatient episode recorded in the inpatient table.
Perinatal - LOW COMPLEX	Show this lozenge when: there is an open to referral to a team type PeriNatal.
Personality Disorder- LOW COMPLEX	Show this lozenge for SU with ICD diagnosis code F60 or F61 recorded in EPR when this ICD code is associated to an open referral, as well as those open to PD Hub.
Psychosis- LOW COMPLEX	Show this lozenge for SU with ICD diagnosis code F20-29 when this when this ICD code is associated to an open referral

Complexity Factors and agreed rating

Recent Discharge - HIGHLY COMPLEX	Show this lozenge when the SU has been discharged from hospital (including OOA bed) within the preceding 28 days.
s117 - LOW COMPLEX	Show this lozenge where SU is entitled to 117 after-care according to the MHA event table we receive.
S2 - - HIGHLY COMPLEX	Show this lozenge when there is an open S2 in the MHA event table.
S3- - HIGHLY COMPLEX	Show this lozenge when there is an open S3 in the MHA event table.
s37/41- - HIGHLY COMPLEX	Show this lozenge when there is an open S37/41 in the MHA event table.
s42- - HIGHLY COMPLEX	Show this lozenge when there is an open S42 in the MHA event table.
Sodium Valproate - LOW COMPLEX	Show this lozenge when there is a S1 Sodium Vaproate alert recorded.
Substance diagnosis - LOW COMPLEX	Show this lozenge for SU with ICD diagnosis code F10-19 recorded in EPR (excluding F17: tobacco-related) when this ICD code is associated to an open referral.
Substance Hx- LOW COMPLEX	Show this when the SU has a substance related diagnosis code associated to an open referral this includes Code F10-F19 (and excludes F17 - tobacco related)
SUSPENDED UNTIL DATA AVAILABLE Depot - LOW COMPLEX	SUSPENDED UNTIL DATA AVAILABLE Show this lozenge when there is a S1 depot alert recorded.
SUSPENDED UNTIL DATA AVAILABLE Red Board - HIGHLY COMPLEX	SUSPENDED UNTIL DATA AVAILABLE Show this lozenge when SU is identified as being marked on the team red board (data to be provided as a bespoke table by BI team)
SUSPENDED UNTIL DATA AVAILABLE Safeguarding Adults- COMPLEX	SUSPENDED UNTIL DATA AVAILABLE Show this lozenge when safeguarding activity is recorded as ticked in the safeguarding tab (this includes currently ticked only).
TOC - Transfer of Care - LOW COMPLEX	Show this lozenge when there is more than one referral open to a team type CMHT.
Urgent 7 - LOW COMPLEX	Any contact with team type Urgent Care in the preceding 7 days - use referral only.
Are there any combinations of 2 complexity factors that you would consider 'Highly Complex'?	When both SMS and child are recorded as present, show the SU as highly complex. Also Safeguarding and Child.
